### ABOUT THE SPEAKERS

**Kenneth A. Bravo,**  
*retired partner, Ulmer & Berrne LLP*

Ken recently retired as a partner at Ulmer & Berne in Cleveland where his practice focused on business litigation, securities arbitrations and the defense of white-collar criminal matters. Before going into private practice in 1979, Ken spent the first 12 years of his career as a federal prosecutor handling organized crime and major fraud cases. An early user of computers, Ken had his own computer in his office before the law firm installed them everywhere. Ken has long been a fan of what he calls “good” PowerPoint presentations and an equally vocal critic of “bad” ones.

**Antoinette (Toni) Bacon**

*Assistant United States Attorney, Northern District of Ohio*  
Toni has served as an Assistant United States Attorney in the Northern District of Ohio for nearly seven years and for nearly six years prior to that was a Trial Attorney with the Antitrust Division of the Justice Department in Cleveland. Toni has worked on several very high profile public corruption cases, including the five-year investigation into corruption at the highest levels of County government. This investigation led to 61 convictions, including a County Commissioner, County Auditor, 2 sitting judges, a City Council member, 9 attorneys (5 former prosecutors), 2 union leaders, 2 school board presidents, 2 senior hospital executives, 11 County employees and 30 business owners. During the trial of former County Commissioner Jimmy Dimora, Toni very effectively used a PowerPoint presentation in closing argument to summarize the two month trial testimony of 80 witnesses and 1400+ exhibits.

**Judge Dan Aaron Polster,**

*United States District Court, Northern District of Ohio*  
Judge Dan Aaron Polster was appointed to the federal bench by President Clinton on August 3, 1998. Prior to going onto the bench, he served as a federal prosecutor for 22 years, first as a Trial Attorney with the Department of Justice, Antitrust Division and then for 16 years as an Assistant United States Attorney, handling a wide variety of fraud and corruption cases.
