Cleveland Attorney Honored with Highest Individual Award at Federal Bar Association's National Convention

(Cleveland, Ohio) – Aaron Bulloff, an attorney recently retired from the Cleveland firm of Kadish, Hinkel & Weibel, was awarded the Earl W. Kintner Award for Distinguished Service at the Federal Bar Association's (FBA) 2015 annual convention. This is the highest award the organization confers on an individual.

Bulloff has been active with the FBA- Northern District of Ohio Chapter for more than 20 years, serving as chapter president in 2001-2002 and on multiple local committees, including the host committee for the annual meeting and convention held in Cleveland in 2000 and scheduled to return to Cleveland in September 2016.

Bulloff's national involvement includes serving on the Government Relations Committee, as a member of the National Council since 2001, on the National Resolution Committee, and as Chapter Liaison Officer for the Federal Litigation Section. He was instrumental in efforts to revive and revitalize the FBA Foundation and its Fellows Program, which recognizes individuals who have demonstrated exceptional commitment to and leadership within both the FBA and the legal community. He became an FBA Foundation Fellow when the program was initiated in 2002, one of only 216 Fellows in the national organization, and was later named a Life Fellow. Bulloff served as Foundation chair from 2003-2005 and has served on the Foundation's Board of Directors since 2013.

"For well over 30 years, Aaron has provided dedicated and honorable service to the FBA, both nationally and locally," said Dennis Terez, president of the FBA-Northern District of Ohio Chapter. "He is truly a fitting candidate for the FBA's highest honor. Throughout all his time as an FBA member, he has inspired countless members of our chapter and members of chapters throughout the country to not only become leaders of their local chapter but also to join him in becoming an active voice in the national organization.
