



The Federal Criminal Practice Seminar is scheduled for Friday, August 13, 2021, and is presented by the Federal Public Defender Office, in association with the Northern Ohio Chapter of the Federal Bar Association, and with the assistance of the Cleveland Metropolitan Bar Association. This year, you have the option to attend in person, or by Zoom webinar. We are pleased to bring you an exciting and diverse line-up, with Professor Reginald Oh presenting on bias in the criminal justice system; Christian Grostic on the Sixth Circuit Review; and Professor Mike Benza will give the annual Supreme Court Review. A video presentation by Allison Siegler “*Breaking Out of the Cage*,” will be followed by a panel discussion on litigating pretrial detention by attorneys Ian N. Friedman, Timothy C. Ivey, Carolyn M.
